All bids must be accompanied by a certified check made payable to Nineveh-Hensley-Jackson United School Corporation in the amount of 10% of the amount bid.

The bids will be opened and read aloud at the regular school board meeting of the Nineveh-Hensley-Jackson United School Corporation to be held at 802 S. Indian Creek Drive, Trafalgar, Indiana 46181, on April 9, 2019 commencing at 7:00 pm.

Bid bonds will be returned to the unsuccessful bidders on or April 12, 2019, via mail. Full payment of the bid amount must be made to the Nineveh-Hensley-Jackson United School Corporation no later than April 12, 2019. In the event that the successful bidder fails to pay the full amount of the bid prior to 4:00pm on April 12, 2019, the bid bond submitted by the successful bidder shall be retained by the Nineveh-Hensley-Jackson United School Corporation as liquidated damages.
